The products SPACE LINE are made of polyamide 66 (PA66) in the black colour.

All plastic parts used in this product are "BPA free".

The product is suitable for all kinds of foodstuffs.

Max. time / temperature of use:

The product is intended to come into a short-term contact with a foodstuff: max. 2 hour at temperature up to 100°C.

Migration ratio:

Overall migration - 100 cm² / 100 ml Specific migration - 60 cm² / 100 ml
