

## 3. Description and raw material of the product

The products Oil, vinegar jars VITAMINO are made of colorless glass, silicone sealing and lid of copolymer poly(methylmetacrylate) and styrene in 2 color variations (red, green).



The products Infusers VITAMINO are made of colourless polystyrene and silicone.



#### 4. Purpose of the product

#### Food category:

The products are suitable for all kinds of foodstuffs: dry, aqueous, acetic (pH<4,5), alcoholic, milky, oily.

#### Max. time / temperature of use:

The products are intended to come into a long-term contact with a foodstuff: max. 10 days at temperature up to 40°C. The product can be also use on conditions 70°C / 2 hours or 100°C / 15 minutes.

#### Migration ratio:

Overall migration - 100 cm<sup>2</sup> / 100 ml Specific migration - 60 cm<sup>2</sup> / 100 ml
