The products Healthy containers for the freezer PURITY are consist of colorless plastic dish (polyethylene material - PE) and plastic lids in 3 colors - white, red, green (polyethylene material – PE).

Max. time / temperature of use:

The products are intended to come into a long-term contact with a foodstuff: max. 10 days at temperature up to 40°C.

Overall migration - 100 cm² / 100 ml Specific migration - 60 cm² / 100 ml
